

NSRI x Flight Centre Give & Get Campaign

1. GENERAL TERMS

All persons ("the Donors") agree that the Campaign rules as set out in these terms and conditions ("the Terms and Conditions") are binding on them. A copy of these Terms and Conditions is available at nsri.org.za/campaigns/give-and-get

- 1.1. The NSRI Give & Get Flight Centre campaign is open to any individual 18 years and over ("Eligible Entrant").
- 1.2. The Campaign will run from 01/10/2024 at 00h00 to 31/12/24 at 23h59 (the "Campaign Period")
- 1.3. In order for the Donor (i.e. any Eligible Entrant making a monetary donation to NSRI in terms of this campaign) to qualify for the Flight Centre voucher ("Reward"), a monetary donation made during the campaign period as set out in clause 1.4 below must be made through the dedicated NSRI/Flight Centre Campaign landing page during the campaign period.
- 1.4. Only one donation amount can be made in a single transaction to receive a qualifying Reward:
 - 1.4.1. Donate R250 (Two Hundred and Fifty Rand) and Get R500 (Five Hundred Rand) Flight Centre voucher.
 - 1.4.2. Donate R500 (Five Hundred Rand) and Get R1000 (One Thousand Rand) Flight Centre voucher.
 - 1.4.3. Donate R750 (Seven Hundred and Fifty Rand) and Get R1,500 (One Thousand Five Hundred Rand) Flight Centre voucher.
 - 1.4.4. Donate R1,000 (One Thousand Rand) and Get R2,000 (Two Thousand Rand) Flight Centre voucher.
 - 1.4.5. Donate R2,000 (Two Thousand Rand) and Get R4,000 (Four Thousand Rand) Flight Centre voucher.
- 1.5. If a Donor is interested in making more than 1 (one) donation during the campaign period, the relevant campaign donation form must be completed for each qualifying donation.
- 1.6. Donations received after the closing date of the campaign will not qualify to receive a Reward.
- 1.7. General donations to the NSRI not made through the dedicated NSRI/Flight Centre landing page as well as donations made for entries into NSRI competitions do not qualify to receive a Reward.
- 1.8. NSRI may in its sole discretion elect to discontinue the Campaign at any time during the Campaign Period.
- 1.9. No Reward may be exchanged/redeemed for cash.
- 1.10. A Reward can only be redeemed once.
- 1.11. Rewards are non-transferrable and non-refundable.
- 1.12. If the Donor's unique PIN code or Flight Centre voucher expires and is not used, the Donor will not be issued another PIN code or Flight Centre voucher.
- 1.13. Qualifying NSRI - Flight Centre Give & Get campaign donations will not qualify for a Section 18a Tax certificate.
- 1.14. Unidentified donations will not be allocated unique Reward PIN codes.
- 1.15. Participation in the Campaign and acceptance of any Reward is subject to acceptance of the terms & conditions as set out, which shall be automatically applied

- 1.16. NSRI may in its sole discretion amend these Terms and Conditions at any time, without notice, and such amendments shall be deemed to have taken effect from the date of publication of the revised Terms and Conditions on its website. The onus rests on the Donor to check the website for updated Terms and Conditions.

2. HOW TO QUALIFY

- 2.1. Donors will donate via the dedicated NSRI/Flight Centre Campaign website landing page.
- 2.2. It is the Donors responsibility, to ensure when entering the Campaign to provide the correct details upon donation. Failure to do so, will result in an unsuccessful delivery of a qualifying prize and potential to forfeit such prize if validity periods lapse.
- 2.3. All payments will be verified by Paygate.
- 2.4. Qualifying Donors will be sent an email including a unique PIN code and online redemption platform weblink.
- 2.5. The unique PIN code sent via email to the Donor is valid for 30 (thirty) calendar days from date of issue ("Pin Validity Period").
- 2.6. The Donor must log onto the redemption platform to redeem the qualifying Reward by capturing the unique PIN.
- 2.7. In the event that the Donor does not log onto the redemption platform within 30 (thirty) calendar days from the date of the unique PIN code being issued and sent via email, the Flight Centre voucher will be forfeited.
- 2.8. The Donor is required to access the redemption platform with the unique PIN sent to the Donor and the Donor is required to accept the campaign T&C.
- 2.9. The Donor redeems the qualifying Flight Centre voucher.
- 2.10. A Reward will be allocated to the Donor via SMS.
- 2.11. Once the Donor has redeemed the Reward on the NSRI redemption platform, it will have a validity period within which to redeem Reward, as per the below.
- 2.12. The Donor may only make a booking 48 (forty-eight) hours after receipt of their Flight Centre voucher by SMS.

3. FLIGHT CENTRE VOUCHER TERMS

- 3.1. The Flight Centre voucher is governed by the following terms and conditions:
 - 3.1.1. This Reward entitles the Donor to either a R500 (Five Hundred Rand), R1,000 (One Thousand Rand), R1,500 (One Thousand Five Hundred), R2,000 (Two Thousand Rand) or R4,000 (Four Thousand Rand) Flight Centre voucher.
 - 3.1.2. The Flight Centre voucher is valid for 6 (six) months from date of issue.
 - 3.1.3. All bookings must be made directly with the Flight Centre on the number provided to the Donor. The Flight Centre contact number will be provided to the Donor when they have received their Flight Centre voucher via SMS (no bookings permitted via online and instore).
 - 3.1.4. The Flight Centre voucher is non-transferable and cannot be exchanged for cash or credit.
 - 3.1.5. Only 1 (one) voucher can be used per Flight Centre booking.
 - 3.1.6. One of the guests travelling must be the Donor who made the relevant donation.
 - 3.1.7. In the case of flights when using 1 (one) voucher to book for more than 1 (one) person, all flights need to be taken simultaneously, with all passengers, flying to

the same destination, on the same flight. Flights cannot be split across multiple flight routes, dates, or people.

- 3.1.8. Bookings are subject to limited availability. In the event that dates requested are not available, the Donor will be required to provide alternative dates.
- 3.1.9. Should the booking value be lower than the Flight Centre voucher, no change will be issued, nor can the remaining value be redeemed on another transaction, nor at another time. The Flight Centre voucher value must be redeemed in full in a once off transaction.
- 3.1.10. If the value of the booking exceeds the value of the voucher, the balance is payable by the Donor to Flight Centre, (including but not limited to surcharges and insurance at the time of the booking or after).
- 3.1.11. This Reward operates on an e-ticket system and presentation of an ID document will be required when checking in.
- 3.1.12. Cancellations or changes after confirmation of booking will not be permitted.
- 3.1.13. NSRI and its agencies cannot be held liable for any changes to flight schedules, routes and destinations or loss of baggage.
- 3.1.14. Flight Centre vouchers codes cannot be used in conjunction with any other promotional offer.
- 3.1.15. Flight Centre vouchers issued under this campaign may not be combined with any other vouchers issued under other campaigns or competitions at the time of redemption
- 3.1.16. Flight Centre vouchers are subject to the rewards partner's regular terms and conditions, which are subject to change, unless otherwise specified in this section.
